Mayor Report Summary:

- Pennsylvania State Police (PSP) Report: none received

- Emergency Management (EM):
 - Fire Police Requests: none received
 - Weather Emergencies:
 - York County Office of Emergency Management (OEM) provided numerous National Weather Service (NWS) weather briefings preceding the December 13 and 24 storms which were passed to Borough Council (BC) Vice President for collaboration. I issued a Snow Emergency Declaration (SED) for the December 13 storm from which we received 4" of snow. No SED was issued for the December 24 storm.
- Meetings/Training:
 - On Wednesday, December 10 the York County OEM issued the quarterly Emergency Management Coordinator (EMC) training dates. The first will be held on Wednesday, January 7 from 6:00-8:00 PM. NWS State College will make a presentation on NWS Slack and winter weather outlooks/information. There will also be some updates on the state of OEM and the many changes that have occurred. Information will also be provided on major events/projects happening in 2026. Future quarterly EMC training dates are April 8, July 8 and October 7.
 - On Wednesday, December 17 in preparation for my Oath of Office preceding the biennial BC reorganization meeting, I had my Affidavit of Residency (AoR) notarized. The AoR was a prerequisite for the Oath of Office which would be administered by District Magistrate Judge Lindy Sweeney, who I met that afternoon. Per Pennsylvania Statute Title 8, Chapter 10, § 1002, copies of these documents are to be filed with the Borough Secretary and retained for six years.
